

Terms Of Service and End User License Agreement Songbooks Online

This is a legal agreement between you and KaraokeWare Inc. as provider of the Songbooks Online subscription service, including any and /all other authorized agents in reference to this agreement ("Providers"), stating the terms that govern your use of the Songbooks Online service (Service). This agreement – together with all updates, additional terms, software, licenses and all Songbooks Online rules and policies collectively constitute the agreement between you and the Providers. If you do not agree to these terms, you must discontinue use of the service. You must accept and abide by these terms as presented to you. Changes, additions or deletions are not acceptable, and Providers may refuse access to the Songbooks Online service for your non-compliance with any part of this agreement.

By continuing to use the service you confirm that: You are 18 years of age or older.

You have read and understood the present agreement in full. You agree with all the clauses of the present agreement.

Definition of Songbooks Online service

Providers, are the providers of the Songbooks Online service (the 'Service') that permits Smart device users to download and install specially designed apps that allow them to search and submit Karaoke song requests directly to the Karaoke host from the convenience of their Smart device

Age requirements for use of the Service

This Service is available for individuals aged 18 years or older.

System Requirements

Use of the Service requires a compatible device, Internet access (fees may apply), and certain software (fees may apply), and may require obtaining updates or upgrades from time to time. Because use of the Service involves hardware, software, and Internet access, your ability to use the Service may be affected by the performance of these factors.

High-speed Internet access is strongly recommended.

You acknowledge and agree that such system requirements, which may be changed from time to time, are your responsibility. The Service is not part of any other product or offering, and no purchase or obtaining of any other product shall be construed to represent or guarantee you access to the Service.

Your Information

You agree to provide accurate, current, and complete information required to register with the Service and at other points as may be required in the course of using the Service ("Registration Data"). You further agree to maintain and update your Registration Data as required to keep it accurate, current, and complete. Providers may terminate your rights to any or all of the Service if any information you provide is false, inaccurate or incomplete. You agree that Providers may store and use the Registration Data you provide for use in maintaining your account and balance.

User Account and Security

Account and Password. As a registered user of the Service, you may establish an account ('Account'). You are solely responsible for maintaining the confidentiality and security of your Account. You should not reveal your Account information to anyone else or use anyone else's Account. You are entirely responsible for all activities that occur on or through your Account, and you agree to immediately notify Providers of any unauthorized use of your Account or any other breach of security. Providers shall not be responsible for any losses arising out of the unauthorized use of your Account.

Security. You agree not to violate or attempt to violate any security components of the Service. You agree not to attempt to, or assist another person to, circumvent, reverse-engineer, decompile, disassemble, or otherwise tamper with any of the software and/or website components related to the Service for any reason whatsoever ('Usage Rules'). Usage Rules may be controlled and monitored by Providers for compliance purposes, and Providers reserve the right to enforce the Usage Rules with or without notice to you. You will not access the Service by any means other than through software that is authorized by Providers for accessing the Service. You shall not access or attempt to access an Account that you are not authorized to access. You agree not to modify the software in any manner or form, or to use modified versions of the software, for any purposes including obtaining unauthorized access to the Service. Violations of system or network security may result in civil

or criminal liability.

Service Payment

Providers provide chargeable Services. You pay for the Service before the Service is provided (prepayment) according to rules and rates. The base cost to you for Songbooks Online service is \$14.98 per month or \$99.98 per year plus taxes as applicable depending on the selected subscription plan, charged to the Payment Method you have provided. All fees and charges are non-refundable. From time to time, Providers and/or their business partners may extend special rates and/or promotions that can change the base price for the Service.

Because the Songbooks Online Service is offered in multiple time zones, for consistency, a "day" for purposes of these Terms of Use begins at 12:00 a.m. Eastern Time and ends at 11:59 p.m. Eastern Time of that same calendar day.

By signing up for your Songbooks Online subscription, you are expressly agreeing that we are authorized to charge you a monthly or annual subscription fee, any other fees for additional services you may purchase, and any applicable taxes in connection with your use of Songbooks Online to the credit card or other payment method accepted by Providers ("Payment Method") that you provided during registration. If your Payment Method expires and you do not update your Payment Method information or cancel your account, you authorize us to continue billing, and you will remain responsible for any uncollected amounts.

As used in these Terms of Use, "billing" shall indicate either a charge or debit, as applicable, against your Payment Method. The subscription fee will be billed at the beginning of your subscription or expiration of your free trial period, if any, whichever is earlier, and on each monthly or annual renewal thereafter unless and until you cancel your subscription or the account or service is otherwise suspended or discontinued pursuant to these Terms.

We automatically bill your Payment Method monthly or annually on the monthly or annual expiration date. However, if you change your Payment Method, this could result in changing the day upon which you are billed. In the event your subscription began on a day not contained in a given month, we bill your Payment Method on the last day of such month. For example, if you became a paying subscriber on January 31, your Payment Method would next be billed on February 28. You acknowledge that the amount billed each month may vary due to promotional offers, changes in your subscription plan, and changes in applicable taxes, and you authorize us to charge your Payment Method for the corresponding amounts. If Providers change the subscription fee or other charges for Songbooks Online from time to time, we will give you advance notice of these changes by email. However, we will not be able to notify you of changes in any applicable taxes.

Very rarely, if there are special circumstances where Providers determines it is appropriate (e.g., the Songbooks Online service is unavailable for days due to technical difficulties), we may provide credits to affected subscribers. The amount and form of such credits, and the decision to provide them, are at Provider's sole and absolute discretion, and the provision of credits in one instance does not entitle anyone to credits in the future under similar or different circumstances.

Refunds

All sales are final. No refunds are provided whatsoever. In the case of cancellation or suspension of your account refunds will not be applicable. In the event that you cancel your subscription, no refund will be given for the unused portion of the current subscription.

Right to Change Prices and Availability of Products. Provider has the right to change prices and availability of any Products at any time.

Electronic Signatures and Contracts. Your use of the Service includes the ability to enter into agreements and/or to make purchases electronically. You acknowledge that your electronic submissions constitute your agreement and intent to be bound by and to pay for such agreements and purchases. Your agreement and intent to be bound by electronic submissions applies to all records relating to all transactions you enter into on this site, including notices of cancellation, policies, contracts, and applications.

In order to access and retain your electronic records, you may be required to have certain hardware and software, which are your sole responsibility.

Usage Rules

Your use of the Service is conditioned upon your prior acceptance of the terms of this Agreement. You agree that your use of the Service constitutes your acceptance of and agreement to use such Services solely in accordance with the Usage Rules, and that any other use of the Service may constitute a copyright infringement. No portion of the Service may be reproduced in any form or by any means. You agree not to modify, rent, lease, loan, sell, distribute, or create derivative works based on the Service, in any manner, and you shall not exploit the Service in any unauthorized way whatsoever, including but not limited to, by trespass or burdening network capacity.

Account Termination.

Account termination by Providers.

If you fail, or Providers suspect that you have failed, to comply with any of the provisions of this Agreement, including but not limited to failure to make payment of fees due, failure to provide Providers with a valid credit card (or other invalid information in relation to payment for services) or with accurate and complete Registration Data, failure to safeguard your Account information, or violation of the Usage Rules or any license to the software, Providers, at their sole discretion, without notice to you may:

Terminate this Agreement and/or your Account, and you will remain liable for all amounts due under your Account up to and including the date of termination; and/or Terminate the license to the software; and/or Preclude access to the Service (or any part thereof)

Termination of the Service

Providers reserve the right to modify, suspend, or discontinue the Service (or any part or content thereof) at any time with or without notice to you, and Providers will not be liable to you or to any third party should it exercise such rights.

General Compliance with Laws

The Service is controlled and operated by Providers from their offices in the USA. You agree to comply with all local, state, federal, and national laws, statutes, ordinances, and regulations that apply to your use of the Service.

Enforcement of These Terms

Providers reserve the right to take steps to enforce and/or verify compliance with any part of this Agreement (including but not limited to Provider's right to cooperate with any legal process relating to your use of the Service and/or Products, and/or a third party claim that your use of the Service and/or Products is unlawful and/or infringes such thirdparty's rights). Providers do not guarantee, represent, or warrant that your use of the Service will be uninterrupted or error-free, and you agree that from time to time Providers may remove the Service for indefinite periods of time, or cancel the Service at any time, without notice to you. You expressly agree that your use of, or inability to use, the Service is at your sole risk. Changes.

Your continued use of the Songbooks Online service following the incorporation will be deemed to constitute your acceptance of any and all such Additional Terms. All Additional Terms are hereby incorporated into this Agreement by this reference.

Notices.

Providers may send you notice with respect to the Service by sending an email message to the email address listed in your Songbooks Online Account contact information, by sending a letter via postal mail to the contact address listed in your Songbooks Online Account contact information, or by a posting on the SongbooksOnline.com. Notices shall become effective immediately.

Governing Law

The laws of the USA govern these Terms and your use of the Service. Your use of the Service may also be subject to other local, state, national, or international laws. You expressly agree that exclusive jurisdiction for any claim or dispute with Providers or relating in any way to your use of the Service resides in the courts of the USA.

Miscellaneous

These Terms of Service constitute the entire agreement between you and the Providers and govern your use of the Service, superseding any prior agreements between you and the Providers. You also may be subject to additional terms and conditions that may apply when you use affiliate services, third-party content, or third-party software. If any part of these Terms of Service is held invalid or unenforceable, that portion shall be construed in a manner consistent with applicable law to reflect, as nearly as possible, the original intentions of the parties, and the remaining portions shall remain in full force and effect. Provider's failure to enforce any right or provisions in these Terms of Service will not constitute a waiver of such provision, or any other provision of these Terms of Service. If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, the other provisions will remain in full force and effect. Providers shall not be responsible for failures to fulfill any obligations due to causes beyond their control.

Other Terms and Conditions

Providers are not responsible for typographic errors.

Providers reserve the right to change the terms and conditions of sale of the Songbooks Online service at any time. Customers are encouraged to review the Sales Policies on a periodic basis for modifications. We may offer a number of membership plans, including special promotional plans or memberships with different limitations. Some of these promotional memberships are offered by third parties in conjunction with the provision of their own products and services. We are not responsible for the products and services provided by such third parties. We reserve the right to modify, terminate or otherwise amend our offered membership plans. Unless otherwise stated differently, period, periodic, month, monthly, year, annual or annually refers to your billing cycle (See "Billing" below).

Billing

By starting your Songbooks Online membership, you are expressly agreeing that Providers are authorized to charge you a monthly or annual membership fee depending on the chosen subscription plan at the then current rate, and any other charges you may incur in connection with your use of the Songbooks Online service to the Payment Method you provided during registration (or to a different Payment Method if you change your account information).

Please note that prices and charges are subject to change with notice.

As used in these Terms of Use,

"billing" shall indicate either a charge or debit, as applicable, against your Payment Method. The membership fee will be billed at the beginning of the paying portion of your membership and each month, year or thereafter unless and until you cancel your membership. We automatically bill your Payment Method each month or year on the calendar day corresponding to the commencement of your paying membership. Membership charges are fully earned upon payment. In the event your paying membership began on a day not contained in a given month or year, we bill your Payment Method on the last day of such month or year. For example, if you started your Songbooks Online membership or became a paying member on January 31st, your next payment date is February 28th and your Payment Method would be billed on that date. You acknowledge that the amount billed may vary from month to month or year to year for reasons that may include differing amounts due to promotional offers, and you authorize Provider to charge your Payment Method for such varying amounts. Ongoing Membership

Your Songbooks Online membership will continue month-to-month or year-to-year depending on the subscription plan in effect unless and until you cancel your membership or we terminate it. You must cancel your membership before its next periodic renewal in order to avoid billing of the next period's membership fees to your Payment Method. Providers will bill the periodic membership fee to the Payment Method you provide to us during registration (or to a different Payment Method if you change your account information). Membership fees are fully earned upon payment.

Cancellation

You may cancel your Songbooks Online membership at any time. PROVIDER WILL NOT PROVIDE REFUNDS OR CREDITS FOR ANY PARTIAL-TERM MEMBERSHIP PERIODS. If bound by a promotional commitment period and you cancel your membership prior to the expiration of the commitment period, you authorize us to impose and bill an early cancellation fee as applicable to your Payment Method on file.

Right to Terminate

Providers reserve the right to terminate or restrict your use of our service, without notice, for any or no reason whatsoever.

Providers reserve the right in its sole and absolute discretion to make changes from time to time and without notice in how it operates the Service. Any description of how the Service works should not be considered a representation or obligation with respect to how the service will always work. Providers are constantly making adjustments to the Service and often these adjustments are not completely captured within these Terms of Use.
